

AN ORDINANCE REGULATING SOLID WASTE MANAGEMENT

(Storage, Collection, Transportation, Processing and Disposal)

Owen County Fiscal Court Ordinance No. 60

AN ORDINANCE pertaining to public health, safety, and welfare; storage, collection, processing, transportation, and disposal of solid waste; providing a penalty for the violation of the provisions of this ordinance and repealing all ordinances in conflict herewith.

Pursuant to Kentucky Revised Statutes 224 and 109 and related administrative regulations, Owen County, including its cities, has been designated as a solid waste management area, based upon a Solid Waste Management Plan approved by the Natural Resources and Environmental Protection Cabinet, hereinafter referred to as "the Cabinet," of the State of Kentucky. In addition, Owen County is acting under powers outlined in KRS 67.083 (3)(0) which provides the authority to manage solid waste by ordinance.

NOW, THEREFORE, be it ordained by the Fiscal Court, Owen County, Kentucky, that this ordinance shall be known as the Solid Waste Management Ordinance. The Owen County Fiscal Court, shall be responsible for the administrative management of this ordinance and the promulgation of rules and regulations authorized in Section 8.

WHEREAS, the Owen County Fiscal Court has built and installed a transfer station which has been in operation as of November, 1989.

WHEREAS, all citizens of Owen County, including private haulers, have the privilege of using the transfer station, which in turn transports the solid waste to a landfill.

WHEREAS, the hours and days available for service, and the amounts charged are published in the county newspaper.

WHEREAS, the transfer station, which is centrally located in the middle of Owenton, therefore requires no one to travel more than twenty miles to use this service.

The provisions of this ordinance shall become effective as set forth above.
