Regular term of the Owen County Fiscal Court held in the Courthouse in Owenton, KY on the 22nd of April, 2014, with Honorable Carolyn Keith presiding. Justices present were Asa Phillips, Teresa Davis, Casey Ellis and Troy Bramblett.

Motion made by Davis 2nd by Phillips to approve and to amend the agenda and add an order of appointment of Casey Ellis to the NKADD and to set the elected officials salaries of the coroner, county attorney, constables and the magistrates.

Motion made by Casey Ellis 2nd by Troy Bramblett to approve the minutes of the April 8th meeting and the special meeting on April 11th. Motion carried unanimously.

Motion made by Teresa Davis 2nd by Casey Ellis to approve the Ambulance Report and the Fiscal Court Committee reports. Motion carried unanimously.

Motion to table the budget of the South Owen Fire Department by Teresa Davis 2nd by Troy Bramblett. Motion carried unanimously.
