Regular meeting of the Owen County Fiscal Court held in the Owen County Courthouse at 6:00 PM on March 10<sup>th</sup>, 2015 with the Honorable Judge Casey Ellis presiding. Justices present Travis Fitzgerald, Stuart Bowling, Todd Spurgeon, and Teresa Davis.

Motion made by Todd Spurgeon 2<sup>nd</sup> by Travis Fitzgerald to approve the previous minutes from February 24<sup>th</sup> and February 26<sup>th</sup> and the March 3<sup>rd</sup> meetings. Motion carried unanimously.

Motion made by Teresa Davis 2<sup>nd</sup> by Travis Fitzgerald to approve the Reports from the Building Inspector, County Attorney, Coroner, Dog Warden, E-911& EMA, Fiscal Court Committee Reports, Jailer, Owen County Public Transit, Parks and Recreation, Road Department and Solid Waste and the Sheriff.
