Motion made by Casey Ellis 2<sup>nd</sup> by Asa Phillips to approve the minutes of the Oct. 22<sup>nd</sup> and Oct. 25<sup>th</sup> meetings. Motion carried unanimously.

Motion made by Teresa Davis 2<sup>nd</sup> by Troy Bramblett to approve reports from Ambulance, Building Inspector, Constables, County Attorney, Coroner, Dog Warden, E-911 & EMA, Fiscal Court Committees, Jailer, Owen Co. Public Transit, Parks & Recreation, Road Dept./Solid Waste and Sheriff. Motion carried unanimously.
