Regular meeting of the Owen County Fiscal Court held on July 24<sup>th</sup>, 2018, at 6:00 p.m. in the Owen County Courthouse with the Honorable Judge Casey Ellis presiding. Justices present were Todd Spurgeon, Stuart Bowling, Teresa Davis and Travis Fitzgerald.

Motion by Teresa Davis 2<sup>nd</sup> by Stuart Bowling to Approve the Agenda with the addition of the Audit Committee Report. Motion carried.

Motion by Todd Spurgeon 2<sup>nd</sup> by Travis Fitzgerald to Approve the Minutes from the July 6<sup>th</sup> and the July 9<sup>th</sup> 2018 meetings. Motion carried.

Motion by Teresa Davis 2<sup>nd</sup> by Travis Fitzgerald to Accept the following Reports: Owen County Public Transit, Owen County Treasures Quarterly Report, Owen County Clerk's Quarterly Report, Owen County Public Works, EMA/911, Owen County Sheriff, Road and Solid Waste Committee, and the Audit Committee.
