Regular Meeting of the Owen County Fiscal Court held on August 14th, 2018 at 6:00 pm in the Owen County Courthouse with the Honorable Judge Casey Ellis presiding. Justices present were Todd Spurgeon, Stuart Bowling, Teresa Davis and Travis Fitzgerald.

Motion by Teresa Davis 2nd by Todd Spurgeon to Approve the Agenda. Motion carried.

Motion by Teresa Davis 2nd by Travis Fitzgerald to Approve the minutes from the July 24th, 2018 meeting. Motion carried.

Motion by Teresa Davis 2nd by Todd Spurgeon to Accept the following Reports; Owen County Treasurer's Report, Owen County Attorney, EMA/911, Owen County Jailer, Owen County Public Works and the Owen County Dog Warden. Motion carried.

Motion by Teresa Davis 2nd by Stuart Bowling to Approve the Re-Appointment of Todd Spurgeon to the NKADD Board of Directors with term ending on September 30th, 2021. Justice Spurgeon abstained from the vote. Motion carried.

Motion by Travis Fitzgerald 2nd by Stuart Bowling to Approve that Willie Hopkins will receive payment for 68 hours of vacation time and that 152 sick hours will be recorded and sent to the County Employees Retirement Systems. Motion carried.
