Motion made by Teresa Davis 2<sup>ND</sup> by Todd Spurgeon to approve the Agenda with the addition motioned by Todd Spurgeon to accept the Owen County Clerks check to close the 2014 General Account excess fees. Motion carried unanimously.

Motion made by Todd Spurgeon 2<sup>nd</sup> by Teresa Davis to approve the minutes from August 5<sup>th</sup>, 2015. Motion carried unanimously.
