**AN ORDINANCE ADOPTING THE FOLLOWING ROADS IN THE FORMER CITY  
LIMITS OF MONTEREY, KENTUCKY AS COUNTY ROADS FOR OWEN COUNTY,  
KENTUCKY NOTWITHSTANDING ORDINANCE NO. 218**

**WHEREAS**, Owen County Fiscal Court finds it to be in the best interest of public safety and convenience, that roads within Owen County be maintained to specific standards, as stated in KRS Chapter 178 and all other state and local ordinances; and

**WHEREAS**, Owen County Fiscal Court desires that all citizens have access to safe and well maintained roads; and

**WHEREAS**, Owen County Fiscal Court may designate and accept roads as county roads; and

**WHEREAS**, per KRS 81.062 the city of Monterey has been administratively dissolved by the Department of Local Government; and

**WHEREAS**, the former city of Monterey had city roads that were maintained by the former City of Monterey, and

**WHEREAS**, per KRS 81.062 all the assets of the former city of Monterey have been transferred to the County of Owen, and

**WHEREAS**, Owen County Fiscal Court finds that the city roads in the former city limits of Monterey, Kentucky are assets and as such are transferred to the County of Owen, and

**WHEREAS**, the former citizens of Monterey deserve to have certain former city roads maintained in that same fashion as county roads; and

**WHEREAS**, Owen Fiscal Court finds that the city streets of the former city limits of Monterey were public roads prior to June 13, 2004, the topography and other extraordinary circumstances, such as location of houses and buildings make the right-of-way requirements of KRS 178.040 inapplicable, and

**“NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF OWEN  
COUNTY, COMMONWEALTH OF KENTUCKY, THAT:”**

That Clyde Street (738 feet), Worth Street (495 feet), High Street (797 feet), Wainscott Street (538 feet), Taylor Street (1654 feet), Hillcrest Street (868 feet), Bridge Street (967 feet) and Ballard Street (400 feet), located in the former city limits of Monterey Kentucky, which more particularly described in the attached map, which is referenced herein and incorporated herewith as Attachment 1, shall be incorporated into the Owen County Road Maintenance System.

Ordinance #246 "Monterey Road Ordinance" authorizes: That Clyde Street (738 feet), Worth Street (495 feet), High Street (797 feet), Wainscott Street (538 feet), Taylor Street (1654 feet), Hillcrest Street (868 feet), Bridge Street (967 feet) and Ballard Street (400 feet), located in the former city limits of Monterey Kentucky, will be adopted into the Owen County Road Maintenance.
