Regular Meeting of the Owen County Fiscal Court held on July 14th, 2020 at 6:00 pm in the Owen County Courthouse with the Honorable Judge Casey Ellis presiding. Justices present were Todd Surgeon, Stuart Bowling, Wayne Harris and Chad Rose.

Motion by Todd Spurgeon 2nd Chad Rose to Approve the Agenda. Motion carried.

Motion by Chad Rose 2nd by Stuart Bowling to Approve the minutes from the June 9th and the June 23rd meetings. Motion carried.

Motion by Todd Spurgeon 2nd by Chad Rose to Accept the following Reports from the Owen Co Jailer, Owen Co Sheriff, Owen Co Attorney, EMA/911, Owen Co Public Works Annual Report, Owen Co Transfer Station Annual Report and the Owen County Treasurer. Motion carried.
