COMMONWEALTH OF KENTUCKY COUNTY OF OWEN ORDINANCE # 292

AN ORDINANCE ESTABLISHING THE UPDATED GEORGRAPHIC BOUNDARIES FOR THE MAGISTERIAL DISTRICTS IN OWEN COUNTY, KENTUCKY

WHEREAS, the United States Constitution requires that members of legislative bodies be elected upon the principle of one person, one vote; and

WHEREAS, KRS 67.045 sets of the legal process requiring the county magisterial boundaries be redrawn based on the population figures resulting from each decennial census; and

WHEREAS, on June 7, 2023, Owen County Fiscal Court appointed three (3) citizen members of the Magisterial Reapportionment Committee; and

WHEREAS, the Committee having met and produced a written report establishing the estimated population of each magisterial district and its recommendations as to the new geographic boundaries of each district and having filed that report with the Owen County Clerk on June, 8, 2023 and each Magistrate having been provided a copy; and

WHEREAS, the Fiscal Court having considered the population data within the report and the Committee's recommendations; and

WHEREAS, the description of the geographic areas of the magisterial districts are listed in the attached report of the Committee which shall be listed as Attachment 1;

Now, therefore, BE IT ORDAINED by the Fiscal County of Owen County, Commonwealth of Kentucky:

THAT the report of the Magisterial Reapportionment Committee is hereby adopted in full by reference and the changes in geographic boundaries as recommended by the Commission to Magisterial Districts 1, 2, and 4, are hereby approved to become effective November 8, 2023.

THAT, all ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

THAT, this ordinance shall take effect and be in full force when passed, published and recorded according to law.

Upon introduction and given first reading before the Owen County Fiscal Court on the
day of 2023 and a motion having been made by Magistrate
Tom Sayback and seconded by Magistrate Travis Fitzgerald and following
discussion the same was approved as the first reading.
